PRE-SCREEN INTERVIEW*

After submitting your company on Gust or emailing your company details, you will be contacted by York Angel Investors to conduct a pre-screen interview. The interview will take place on the telephone and will consist of series of questions involving your investment purpose, valuation, IP, and exit strategy, among others.

SCREENING MEETING*

Should there be a synergy with our company, you will be invited to present to our Screening Committee. This is an informal presentation where your company will be discussed in more detail and will be assessed on its eligibility to present in front of our members

INVESTMENT MEETING*

After receiving approval from the Screening Committee you will be asked to present at our month end Investment Meeting.

This is your opportunity to present to our members and garner interest in your company.

How are applying companies processed?

Companies interested in seeking investment capital from the members of York Angel Investors are first directed to the Gust website via personal referral or our website, www.yorkangels.com . From here, companies are able to fill out our application form and make it accessible to our members. Upon receipt of their application, the company may be sent a notification e-mail confirming the receipt of their application as well as requesting an Application Review Fee of \$39.55 (\$35 + HST). If the company is not within our geographic target area, they may be sent a notification of our inability to proceed.

Once the review fee is received from our approved applicant, we are then able to proceed with a set of pre-screening questions conducted via telephone. The answers to these questions are then reviewed by our Executive and Financial Directors, who then determine whether or not we invite the company to present at one of our upcoming Screening Meetings. Once a company is selected to present at one of our Screening Meetings, they are contacted via telephone with a follow-up e-mail with the details. Presenting companies may also be required to pay an Informal Presentation Fee of \$84.75 (\$75 + HST), due prior to the Screening Meeting.

The final step in processing an applicant is determining their eligibility for our monthly Investment Meeting. If the attending members from the previous Screening Meeting feel that the company is both presentable and likely to be of interest to our members, the company will be invited to present at our upcoming Investment Meeting. The company will then be contacted via telephone, followed by a confirmation e-mail with the necessary details. Presenters for an Investment Meeting, will be required to submit a Formal Presentation Fee of \$197.75 (\$175 + HST), due prior to the Investment Meeting.

If there is any interest expressed in the presenting company by the members and guests at the Investment Meeting, Due Diligence with the company will be arranged shortly after the presentation and will begin shortly thereafter. Please note Guest must become a YAI member before they are able to invest in a deal.
